Letter from the Chairman

Dear Donors and Friends of the Foundation:

Since 1949, the Community Foundation of Warren County has offered many ways for generous people to support the needs of our communities and the dedicated non-profit organizations that serve our citizens. Supported by its donors and guided by its sound investment policies the Foundation, has grown from its modest beginnings in 1949 into a multimillion-dollar organization with total assets over \$97,000,000 as of December 31, 2020.

As the Foundation's Financial Report indicates, the portfolio experienced outstanding growth of over 10% in its investments during the year 2020. The Foundation's conservative investment policies have proved to serve it well through the many turbulent times we have encountered in the economy. We intend to continue to rely on these policies for the foreseeable future.

Over the years the income generated by its assets has enabled the Foundation's Board of Directors to focus on the areas identified in its Resolution and Declaration of Trust: Education, the Arts, Religion, Health, and our Community, which includes support for children and youth; all have been well served.

Our success in fulfilling our mission continued in 2020. The Foundation made grants and disbursements totaling \$2,687,580, including 228 scholarship awards of \$685,375.00. I congratulate all involved, the Donors, Staff, and Directors on these achievements. These totals do not include grants recommended by the holders of donor-advised funds that are approved by the Foundation Board of Directors. These grants totaled \$3,171,187.00

Generous donations from contributors with connections to Warren County enabled us to continue to expand our work on behalf of the many charitable organizations that serve the people of our area. For the year 2020, the Community Foundation received 468 new contributions totaling \$1,885,553. These gifts ranged in size from under one hundred dollars to many generous gifts over \$1,000. They will all serve the philanthropic wishes of the donors; and support the work of the Community Foundation.

As we look back on 70 years of service to the community, and as we look forward to new challenges and opportunities, we remain committed to honoring the wishes of our donors, past, present, and future. This report contains a list of the grants we made using the funds left in our trust; sustaining and enhancing the quality of life in Warren County through philanthropy. We hope these examples of our work will inspire you to become a philanthropist. No gift is too small, there is a need for every dollar you can donate. The seeds you plant with your gift today will help continue to make Warren County a better place to live tomorrow.

From the Executive Director

I am grateful to the Community Foundation Board of Directors for the opportunity to serve the people of Warren County. Every day I work with our important constituencies – our donors, our non-profit partners, and our grant recipients. I enjoy working with our local non-profit organizations to help those in need. Those opportunities and the successes we create together make my days rewarding.

The Community Foundation of Warren County is fortunate to be supported by caring people dedicated to helping others. Their care and concern is expressed in so many ways.

Most of the funds now held in trust for the Foundation were established through wills and estate plans. Other donors established donor advised funds so they could enjoy seeing the benefits their gifts would provide and to control how various organizations were supported by their gifts. At year-end the Foundation had 227 funds, most of them designated for specific purposes.

Scholarship, donor-advised, and donor-designated funds allow the donor a measure of control over how the income generated by the investment portfolio will be used. Unrestricted Funds, which play a key role in the work of the Foundation, provide investment income to be used at the discretion of the Foundation Board of Directors. The income from unrestricted funds is used for scholarships, and to make grants to deserving non-profit organizations. All gifts to the Foundation are important. However, unrestricted gifts provide maximum flexibility in meeting the changing and growing needs of our communities.

The following pages offer a snapshot of our finances and provide a listing of the grants which represent Foundation's most recent work. Every grant we make tells a story about an organization helping to support our efforts in Warren County. Because space limitations do not allow us to tell all the stories in this report, we plan to share some of them on our website.

Near the end of this report, you will find descriptions of the various fund opportunities within the Foundation. If you are interested in supporting one of the organizations we support, or making a donation to support another charitable cause in Warren County, please contact me. I will work with you to make sure your charitable intentions are met now and for the future. It would be my pleasure to help you achieve your goal of helping others through the work of the Community Foundation of Warren County.

The Community Foundation strives to improve and enhance the quality of life in Warren County by providing grants to area non-profit organizations. Because the needs of our communities are wide-ranging, so is the support that we offer.

In 2020, a total of \$3,171,187 was given back to your communities from Foundation funds, including scholarships to area students. We provided grants in fields of interest that touch the lives of all residents on our county: the arts, community, health, and education.



The Arts

Warren County is blessed to have many organizations and programs dedicated to the Arts. The Foundation is proud of its support for a number of these organizations and the programs they provide.

In 2020 the Foundation made a grant to the Struthers Library Theatre sponsoring its Celebrity Series of events.

Helping others develop and express their talents enriches their lives, as well as the lives of those who experience exciting programs in performing and visual arts.



Community

Since community assets enhance the quality of life in Warren County, the Foundation focuses on elements that contribute to the quality of life in our communities.

The photo above represents the payment of \$31,187.00 to the Salvation Army to cover food costs for meals provided during the COVID 19 pandemic.

From recreational development to supplying food and clothing for those in need, the Community Foundation provides support for projects that benefit people all across Warren County.



Health

It is a fact of life that the population of Warren County is aging. However we promote wellness for people of all ages with our funding for programs ranging from pregnancy support to end of life care.

This year the Foundation provided support to Warren General Hospital's acquisition of 3-D Mammography equipment.

Quality of life depends on good health throughout life, and the Foundation is committed to supporting those organizations and programs which help our citizens enjoy the best of health at every stage.



Education

We build the foundation of our future by providing scholarships to local students attending colleges and universities as well as technical schools.

In 2020, the Foundation provided over \$34,000 in scholarship grants to high school students in the Saint Bonaventure Dual Enrollment Program.

Our scholarship program is one of the Foundation's largest expenses. However we also support programs for students in the Warren County School District to help them prepare for post-secondary education and rewarding careers.

Warren Gives has grown every year thanks to the incredible generosity of donors and match pool sponsors!

Each year, the Community Foundation hosts Warren Gives, a sixteen-hour online fundraising event that allows everyone in the county to be a philanthropist, with donations from \$10 to thousands of dollars happily accepted. More than 1,900 donors gave during the 2020 event, and over 100 community organizations benefited.

All money donated grows, thanks to \$55,000 in match pool money from generous sponsors and donors. Match dollars are distributed proportionally among organizations based on the donations they receive. And 100% of donations and match dollars go directly to the organizations— all administrative and processing fees are paid by the Community Foundation of Warren County.
